- 1. The MINISTRY OF HEALTH AND SANITATION (MOHS) has received funds from Global Fund toward the cost of Strengthening Systems for health and scaling up of high impact interventions for HIV, Tuberculosis and Malaria to attain Universal Health Coverage. The Project is implemented by the Ministry of Health and Sanitation (MOHS) through its extension office Integrated Health Project Administration (IHPAU). MOHS-IHPAU intends to apply a portion of this funding to eligible payments under this Contract with reference number MOHS/IHPAU/NACP/GF/SER/NCB/2021/002.
- 2. The MOHS-IHPAU now invites proposals to provide the following consulting services: competent and qualified service providers to support the NFM3 grant HIV programme implementation. Prospective organizations are required to provide detailed information on how they will support the implementation of the grant to achieve the 95;95;95 target in seven high burden districts (Western Area Urban, Western Area Rural, Bombali, Port Loko, Tonkolili, Kenema and Bo).
- 3. Each service provider will focus on specific allocated districts which are categorized into Lots: **Lot 1:** (Western Area Urban, Western Area Rural & Portloko) & **Lot: 2** (Bombali, Tonkolili, Bo & Kenema). Implementation of the NFM3 started from 1st July 2021 and ends 30th June 2024. Interested consultant/service provider can submit application for one or both lots, but no consultant/service provider will be awarded more than one lot. More details on the services are provided in the attached Terms of Reference. The individual consultant contract will run for a period of 30 months. An initial 12 months service contract will be signed with the successful consultant/service provider with the possibility of contract renewable based on successful and satisfactory performance of the ToR.
- 4. No prequalified / shortlisted consultants (firms) exist, therefore request for proposal is open to all qualified and interested firms.
