The Integrated Health Administration Unit (IHPAU) through the Ministry of Health and Sanitation (MoHS) has received funds from Global Fund under the NFM3 Grants towards the cost of **Strengthening System for health and scaling up of high impact interventions for HIV**, **Tuberculosis and Malaria** to attain Universal Health Coverage. The Project is implemented by the Ministry of Health and Sanitation (MOHS) through its extension office – Integrated Health Project Administration Unit (IHPAU). MOHS-IHPAU intends to apply a portion of this funds to eligible payments under this Contract, (hereinafter called "Services") with procurement reference number SL-MOHS/IHPAU/GF/SER/NCB/2021/003.

2. The MOHS-IHPAU now invites proposals to provide the following consulting services (hereinafter called "Services"): Lot 1: Uploading Documents in SUN System and Provision of Training, and Lot 2: TOMPRO ACCOUNTING SYSTEM: Creation of a new Database for the New Funding Model (NFM 3) grant and also the Formatting and uploading of the NFM3 grant budget into the new database for the Ministry of Health and Sanitation, Sierra Leone.

3. IHPAU is currently using Sun Systems 6.2.1 and Infor Query & Analysis for financial data processing and reporting. During the past two years IHPAU has undergone Reprogramming of some of its donor funded projects as well as Staff Restructuring process. As a result, additional staff have been recruited to improve the overall efficiency at IHPAU in terms of grant management. Also since the installation of Suns systems 6.2.1 in 2016, IHPAU has also taken on board new projects which are not currently in the system as well as undergoing reprogramming of exiting budgets already in the Suns system databases.

4. The Sub-Recipients (SRs) have been using Tompro Accounting system for the past 3 years under the New Funding Model (NFM) 2 grant and the Sub-Recipients (SRs) will be implementing the HIV component of the Global Fund under the MOHS, there is a need for the creation of a new Database for the NFM3 grant and also the Formatting and uploading of the NFM3 grant budget into the new database.

5. Against this backdrop, your company has been pre-selected to submit proposals/ bids to train the staff for optimal usage of Sun Systems as well as add/Upload new projects into the Sun System Database and TOMPRO ACCOUNTING SYSTEM: Creation of a new Database for the New Funding Model (NFM 3) grant and also the Formatting and uploading of the NFM 3 grant budget into the new database.

6. **Project Objective and Scope of Work**

The key objective of this engagement is to provide:

Lot 1: Uploading Documents in SUN System and Provision of Training

- Coding and uploading budgets for the Various Projects
- Training for IHPAU's staff in the effective use and management of current Sun Systems

Lot 2: TOMPRO ACCOUNTING SYSTEM: Creation of a new Database for the New Funding Model (NFM 3) grant and also the Formatting and uploading of the NFM 3 grant budget into the new database

- Create the databases for 7 SRs.
- Create the consolidation database in the IHPAU Headquarters.
- Formatting and uploading the NFM3 grant budget for all SRs
- Install TOMPRO software in the headquarters site in Freetown and enable the functionality for several simultaneous users.
- Enhanced the functionality for several simultaneous users.
- Test systems functionality using dummy data as well as existing live data.
- Provide refresher trainings to the SR users, including data capturing and reporting.
- Provide training to MOHS/FA finance and IT Staff on the use of the system including consolidation (data import/export and support to SRs)
- Provide continuous after-sales/installation technical support for the system for a one-year period

3. Only Prequalified / shortlisted International consultant's data (firms) exist for these services, therefore request for proposal is open to all qualified and interested Local and International firms.

4. A firm will be selected under the Least-Cost Selection (LCS) procedures and in a full Technical Proposal as described in this RFP in accordance with the Sierra Leone government procurement regulations
