Procurement Title: For the construction of one integrated, and two ordinary groundwater monitoring stations and one automatic rain gauge in Sierra Leone

The National Water Resources Management Agency has received funds from the United Nations Children Emergency Fund (UNICEF), for the procurement and installation of three groundwater monitoring equipment (two (2) data loggers, and One (1) digital multiparameter paired with data logger for automatic data transmission to NWRMA central server) and one (1) automatic rain Guage in Sierra Leone and now invites sealed bids from eligible bidders.

With sole aim of the Agency to achieve topmost coverage in re-establishing Sierra Leones's hydrological monitoring network is proposing to construct three groundwater monitoring stations and one automatic rain guage within the Kargoro Chiefdom, Moyamba District for a period of four months

The re-establishment of hydrological monitoring networks will compliment similar projects presently on-going to effectively monitor and manage Sierra Leone's water resources.
