Bidding is open to suppliers from all countries, and bidders shall not be under suspension for corrupt and or fraudulent practice. Bidders shall demonstrate compliance with All requirements in the bidding document.

Interested bidders may inspect the bidding document on or before Tuesday 18th May 2021 at the NMSA Administrative office building at 31 Murray Town Road, Freetown, between the hours of 9.00 AM to 4.00 PM GMT daily. Bidding documents may be purchased upon payment of a non-refundable fee of Five Hundred Thousand Leones (SLL 500,000.00), or its equivalent in a freely convertible currency. Payment should be made **into NPPA -Revenue from sale of Bidding documents Account # 0111-0039-81 / BBAN: 000001011100398165** at the Bank of Sierra Leone, and pay-in slip submitted to the Finance and Procurement Units of the agency.

Completed serialized/paginated Bids must be delivered to the address below on or before Friday 28th May 2021 at 11:00 AM. All bids must be accompanied by:

- ❑ Bid Security of Fifty Million Leones (SL Le 50,000,000.00) from a reputable Bank or its equivalent in freely convertible currency;
- ❑ A valid updated tax certificate;
- ❑ A valid business registration;
- ❑ A valid Nassit Certificate (only for Bidders based in Sierra Leone);
- ❑ Three Years audited Financial report
- ❑ Evidence of experience in similar supplies
- ❑ A signed Integrity Pact

Bids will be publicly opened on Friday 28th May 2021 at 11:15 AM, in the presence of bidders' designated representatives (with written permission/authorization from Bidders), and any member of the public who chooses to attend at the address below. Late bids will be rejected and returned unopened to bidders.
