The Republic of Sierra Leone has received financing in the amount of US\$40 million from IDA and US\$20 million from Global Financing Facility (GFF) toward the cost of the Quality Essential Health Services and Systems Support Project, and it intends to apply part of the proceeds to payments for goods, works, non-consulting services and consulting services to be procured under this project. This project is jointly financed by the IDA and Global Financing Facility.

The project includes the following components:

- I. Component 1: Improving Quality, Efficiency and Effectiveness of RMNCAH-N services;
- II. Component 2: Health Systems Strengthening;
- III. Component 3: Mainstreaming Cross-sectoral Collaboration with non-health Ministries and Stakeholders;
- IV. Component 4: Project Management and Monitoring and Evaluation;
- V. Component 5: Contingent Emergency Response Component (CERC)

Goods, Works, Non-consulting Services and Consulting Services to be procured through open international competitive procurement are shown below:

- Procurement of Medical and Supplies (Lab equipment & Consumables; Water quality testing kits; first aid kits etc)
- Procurement of Computers and Office Equipment (Laptop computers; mobile phones; Printers; tablets etc)
- Purchase of Nine Motor Vehicles
- Procurement of Waste Management Materials (Rain Gears, waste Bins, PPEs etc)
- Procurement of Equipment for Lungi Hospital
- Rehabilitation/Construction of Super Hubs
- Rehabilitation of Community Health Centres (CHC)
- Recruitment of Consultant to Pilot Digitalizing user fees collection
- Recruitment of firm to Conduct feasibility study and prepare designs for Medical Waste Management Facility

Procurement of contracts financed by the World Bank will be conducted through procedures as specified in the World Bank's Procurement Regulations for Investment Project Financing Borrowers' (dated July 2016 and revised in November 2017, August 2018 and November 2020), and is open to all eligible firms and individuals as defined in the Procurement Regulations. After project initial budget and work plan preparation, the World Bank shall arrange the publication on its external website of the agreed initial procurement plan and all subsequent updates once it has provided a no objection.

Specific Procurement Notices (SPN) for contracts subject to open international competitive procurement will be announced, as they become available via STEP on [UN Development Business](#) online, on the World Bank's external website and national newspapers in Sierra Leone.
